Closing Date: All entries must be received by October 16th, 2010.

Eligibility: This event is open to all Sirs in good standing, and those on a Sirs waiting list. Wives of active Sirs, regardless of age or lady guests 50 years or older are welcomed. All entrants must have a current USBC Membership.

Entry Fees: Singles is \$17.00, Doubles is \$17.00, Optional All Events is \$5.00.

(Total per bowler for Singles, Doubles, and All Events is \$39.00)

Fee breakdown per entry: Lineage = \$7.75, Prize Fund = \$7.00, State Sirs Fund = \$0.35, and Misc expenses = \$1.90

Average: 1. Use highest USBC sanctioned average of 21 games or more as of April 15th, 2010. USBC CERTIFICATE # 04723
2. If none, use current highest USBC sanctioned league average of 21 games or more at the time of submitting this entry.
3. If none, bowler will bowl scratch. (Average will be entered as 210)
4. USBC Rules 319A2, 319D, and 319E will apply. The Tournament Committee has the right to re-rate any bowler.
Any re-rated bowler will be notified prior to the start of the tournament.

Handicap: Singles handicap is based on 100% of the difference between the bowler's average and 210. The Doubles Team handicap is 100% of the difference between the Doubles team combined average and 420.

Divisions: "A" Division will consist of Sirs with an average in the upper half of all the entrants. "B" Division will consist of Sirs with an average the lower half of all entrants. "C" Division will consist of all women entered in the singles event regardless of average.

Prizes: Prize money will be distributed on a ratio of one (1) prize for every six (6) entries. Prize money will be sent to the branch bowling chairman or person designated on the entry form. 100% of all prize money collected will be returned
