Membership in **Sons In Retirement** is open to men retired from full time occupation, regardless of age, race, color or religion.



John and his wife Teri have two sons and three grandchildren.


Hobbies include boating and wine tasting.

We have completed 11 of 35 weeks with Team 3 (Misfits) led by Shirley Madsen, Dottie Harris, Pam Jarvie, and Greg Mattus in first place by 5 games over Team 15 (Brentwood Café) led by Tami Fanucchi, Ken Fanucchi, Karen Capra, and Dennis Pachucki.



At this point season highlights so far are: for men, Jose Arroyo – scratch series 708, scratch game – Curtis Manning 282, handicap series is Vic Vasquez with 753, and handicap game goes to Warren Young with 295. There were 22 SIR tournaments this year, ranging in location from Yuba City to Modesto, and San Jose to Carson City and Reno. Of those 22 tournaments our SIR group entered 15 of them. Not only entered but placed as well. There were 63 categories of cash places paid to our group (Branches 161 and 108) which includes singles, doubles, and team events. This means that well over 100 checks were cashed (approximately 125) this year. Believe it or not, this was down some from 2012.

Most of the tournaments were down about 30% in attendance from 2012, ours included with 105 this year against 140 from 2012. Hopefully 2014 will bring more participation although I believe that our branches did well.

The 2014 issue of our Branch 161 Handbook will soon go into production/printing, for distribution at our January luncheon meeting. Please check the 2013 Handbook, and be sure to communicate any errors or updates in your contact information (names, address, phone number, email address) to LaVan Bock. LaVan will update the Branch Roster, which will be electronically imported into the Handbook. Once the Handbook is in production, we will be unable to make any changes/corrections until the 2015 Handbook.

The Roster is also used to maintain our mailing list and the 'Birthday boys' list; So, it's important that this information is correct. LaVan will accept updates/corrections for the Roster any time of year.

Membership Requirements & Principles

Membership is open to men retired from full time occupation, regardless of age, race, color or religion. There are no dues, fees or assessments. Member volunteers and staff administer and govern all branch activities. Voluntary member contributions provide for these activities. SIR supports no outside cause or interest. We prohibit discussions of politics and religion or the selling of anything to any member. The only requirements to join SIR are that a man be retired, or semi-retired, and sponsored by an active member.

Attendance Policy (Revised July, 2012)

Luncheon meetings are normally held on the second Tuesday of the month at the Discovery Bay Country Club, 1475 Club House Drive. (There are exceptions to when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this issue).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion. If you cannot attend, you are required to notify the Attendance Chairman by the Friday prior to the luncheon meeting or you may be charged for the luncheon.

Regular members missing three consecutive meetings without notifying the Attendance Chairman, or missing more than five (5) meetings within the last 12 months for any reason, shall be notified by letter or email of the Branch Executive Committee's pending action to terminate their membership.

Certification of attendance at another branch will be considered a credit to attendance.

Responsibility Clause
