Our branch continues to operate as many activities as feasible, with covid mandates and related issues creating obstacles along the way. As you likely have heard by now, our county is now requiring proof-of-vaccination (or a negative covid test) to enter restaurants and other indoor



public spaces. In this case SIR was ahead of the game. Most dining establishments have ongoing staffing issues, as well as product shortages that are significantly impacting their operations. The country club has these issues, but is committed to supporting our monthly luncheon meetings, and I'm sure you've noticed a few new faces there. The restaurants Dennis Pachucki has been working with to re-start Dinner With the Ladies are all saying they cannot serve groups of our size for now, so this activity is unfortunately suspended until the situation improves.

So, while we have a number of activities occurring, there are some we cannot do for now. We are as active as we can be, but with our annual dues cycle coming up, some of you may be wondering what you're paying for. Maybe a little transparency would help. There are items the branch has to fund on an ongoing basis, regardless of how many activities are conducted. This is not an all-inclusive list, but provides an overview:

All SIR branches pay an assessment quarterly to State SIR, based on the number of members. Approximately 80% of this assessment goes toward insurance.

For the past couple years, we've actually charged members less for lunches than paid to the country

club. Why? They increase prices annually, and not in whole dollar amounts. We need to keep payment simple, and dues help offset any deficit.

Free luncheon tickets for speakers, new member sponsors, and winners of our drawings.

Awards for member appreciation milestones and recognition.

We send a memorial card and plant a tree in memory of each Fallen SIR (more than we wish for).

Bottles of wine are given to members who bring guests, and the guests receive a 50% lunch discount.

Costs for printing ink, paper, envelopes, postage, etc to conduct branch business.

Occasionally, not often, a big ticket purchase needs to be made. An example is the large screen monitor we are now using for presentations. Our SIR branch shared the cost of this purchase with the country club.

All this is said just to help members understand that dues are a necessary component to the operation of our branch. We are a not-for-profit organization run by volunteers and will never charge members more than is needed to maintain a healthy branch. I'm sure

SIR Golf at Rancho Solano September 7, 2021

Sixteen golfers played at a very nice Rancho Solano Golf Course. The slight wind made the 99-degree temperature almost tolerable.

There were 2 flights and three ways you could win money.

In the A flight. The team of Mensch, Lyman, Donnell, and Lippstreu narrowly edged their rivals by one stroke winning \$14 per player. There were 6 skins in the A flight worth \$6 each. 3 were won by Tom Denning and one each to Lippstreu, Mensch, and Welton. In the low gross/low net competition in this flight Tom Denning earned \$12 in the low gross section with a score of 80. Second place went to Lee Donnell earning \$6. The low net winner was Larry Mensch earning \$12 with a net 74 and the second place went to Johnny Welton earning \$6.

In the B flight. The team of Douglas, O'Connell, Fry, and Spann defeated their rivals by 7 strokes and earned \$14 each. There were 8 skins worth \$5 each and Ken Fanucchi won 5 of them. John Douglas, Vince Vargas and John Fry won 1 skin each. In the low gross/low net competition, Ken Fanucchi earned \$12 with a 1st place low gross score of 98. Second place went to John Fry for \$5. The low net first place, earning \$12, was Vince Vargas with a score of 76. Jim Spann earned \$5 for second place.

The Paradise Valley course in Fairfield, is where we will hold our last tournament of the year on Tuesday, October 19, 2021.

It is our Championship Tournament for Branch 161. It is an individual low net competition. The winner gets his name on the perpetual trophy. Any Sir is eligible to play and win prize money if you have a valid GHIN handicap. To earn the Championship Title, you must have played in at least 2 of our tournaments and be a member of Branch 161.

Membership Requirements & Principles

(revised 2019)

Membership is open to men, regardless of age, race, color, or religion. Member volunteers and staff administer and govern all branch activities. Nominal membership dues help provide for these activities. SIR supports no outside cause or interest. We prohibit discussions of politics and religion or the selling of anything to any member. Prospective members must be sponsored by an active member.

Attendance Policy (Revised July, 2012)

Luncheon meetings are normally held on the second Tuesday of the month at the Discovery Bay Country Club, 1475 Club House Drive. (There are exceptions when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this newsletter).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion. If you cannot attend, you are required to notify the Attendance Chairman by the Friday prior to the luncheon meeting or you may be charged for the luncheon.

Regular members missing three consecutive meetings without notifying the Attendance Chairman, or missing more than five (5) meetings within the last 12 months for any reason (not counting May and December), will have their membership reviewed by the Branch Executive Committee (BEC), and may receive a notice from the BEC of their decision to consider terminating the absent Sir's membership.

Certification of attendance at another branch will be considered a credit to attendance.
