Golf News, Johnny Welton

Although there are no events for December or January, this is a busy time for golf. Golfers are now paying for their 2026 NCGA dues and registering for the February through November SIR Branch 161 events. There are also a few leftover items from 2025 to be taken care of at our January meeting. A goal for the New Year is to continue posting those golf scores!



The top ten money winners for 2025 were very close with one exception. Tenth: John Sutton; Ninth: David Vicentio; Eighth: Mike Carmichael; Seventh: Bill Konold; Sixth: Ron Benge; Fifth Tom Denning; Fourth: Jim Spann; Third: Dan Lippstreu; Second: Isao Nishijima. They had a range in prize money of \$99 to \$70. The exception was our SIR Branch 161 Individual Champion, Dennis Pachucki. He amassed a fortune of \$142! But that is not all; At the January meeting he will receive recognition as our "Sandbagger of the Year" and receive a very appropriate t-shirt! He also receives the trophy as the "2025 Top Money Winner." We can't make it too easy for him to defend his championship in 2026.

We are appreciative of the members of the Golf Committee for their support, advice, and leadership during the past season. Tom Denning, Lee Donnell, Mike Kaufman, Bill Konold, Dan Lippstreu, Dennis Pachucki, John Sutton, David Vicencio, and myself. They meet 2-4 times per year to advise/decide on the policies, costs, prizes, courses, etc. Their work is important to the success of the SIR Golf program. Two major actions during 2026 will be to increase the membership of the Golf Committee and to replace the Golf Director for 2027. If the new Golf Director joins the committee in 2026 there will be an opportunity to learn how the process has worked as a member of the committee before taking on the responsibility of the operation in 2027.

At the Golf Committee's meeting on December 8, 2026, the rates for participation were determined for 2026. Green fees have been both up and down at specific courses for next season, but the average increase is \$2.00 per person per event. Prizes will increase by \$2.90. The Individual Championship event will increase by \$3.80 for a total expected increase of \$8.70 in 2026. In 2025 the individual event cost was \$65. For 2026 the basic event cost will be \$70. Refunds will be made based on the Cancellation Policy - up to the full amount may be refunded. Once again, a preseason price for ten or nine events will be offered if paid in full before February 10, 2026. Ten events will be offered at an increase of \$30 from last year and a total of \$600 (\$100 discount). Nine events will be offered at an increase of \$45 from last year and a total of \$560 (\$70 discount). Cancellations will result in a recalculation of costs per the number of events completed. Refunds will be made according to policy after the completion of the golf season. There is a potential, based on the ending balance in the SIR Branch 161 Golf Custodial Account, for many surprises throughout the 2026 season. The Golf Committee is committed to providing players with a quality experience and value at each golf event.

The 2026 Golf Schedule is included in this newsletter. Put these dates on your calendar now.

I hope you enjoy your Holiday Season. It will be an exciting golf season in 2026! Please plan to join us.

Attendance Policy

Luncheon meetings are held on the first Tuesday of the month at Club Los Meganos at Trilogy in Brentwood. (There may exceptions when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this newsletter).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion.
