

Time to get serious about golf. The 2026 SIR Branch 161 Golf Events Schedule is enclosed. Please review and decide now - while the discount is still available. As always, just email me if you want to register for one or all the events. The discount is significant this year and it really helps me not to be collecting money for each event. Below are the fees approved for 2026. Mail your check (made out to "SIR Branch 161") as soon as possible to be sure you make the February 10th deadline for discounted rates. Events Fees for 2026

- Basic Rate for each event: \$70 with refund before any penalties @ full amount.
- Pre Pay for all 10 events: \$600 if paid by 2/10/26 with refund triggering a recalculation of rate based on the number of events paid.
- Pre Pay for 9 events: \$560 if paid by 2/10/26 with refund triggering a recalculation of rate based on the number of events paid.

The cancellation policy remains the same - late cancellation will be assessed after the due date (\$15) when SIR is not charged. Full charge will be made when the club is charged. Refunds will be made after the season is completed.

Posting Scores

Please continue to post scores all year - every time you play nine or eighteen holes. Approximately one week prior to an event, I will automatically check the number of postings and apply penalties to the competition. You are responsible for there being 25 postings for the past 12 months - each month - or contacting me if you think I should make an exception.

Match Play

Soon I will be sending out the "Guidelines for Play 2026" for your review. Our first event is Tuesday, February 24 at 9:30 am on the Shadow Lakes Course - We will again encourage the Rough Riders group to join us ... this year it will be a "Match Play Competition." Why, you ask? So that we can practice the Match Play format in preparation for the competition with SIR Branch 8 Concord. We are hosting for the first time in June at Elkhorn Golf Course in Stockton. We won three or four competitions in a row and then lost our mojo! It is time to get it back! We need to know the rules if they are to work in our favor. We need to know what to do when the structure changes on the day of play. We need to learn strategies that might give us an advantage. I will send out some information for you to read before our February event and at 8:15 am prior to the event at Shadow Lakes, there will be a 45 minute clinic on Match Play followed by a Question-and-Answer session or time for warmups. I won't waste your time. The information will be helpful. You will know how to depend on and utilize the "team" effort. Don't get shortchanged on hits available or strokes. Know how to monitor your competition. This is more than showing up to hit a golf ball. We want to be prepared to WIN!



Tournaments:


We took 9 bowlers to Napa on Tuesday 1/20 and are waiting for final results. Expectations are not high as we found difficult (lots of dry) lane conditions.

Attendance Policy

Luncheon meetings are held on the first Tuesday of the month at Club Los Meganos at Trilogy in Brentwood. (There may exceptions when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this newsletter).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion.
