# Membership Goal -2015

At our luncheons this year, we have had a number of guests. Several of our members have been reaching out and inviting new guys to vis-



it us. Good job guys! Most of those guests have become members and are enjoying getting to know new people, being reacquainted with former friends (it's a small world), and becoming involved in our activities.

Our Branch's membership goal for this year is 159 members by year's end - i.e. 2014's membership + 1 is the SIR, Inc. 2015 goal for each Branch. The deadline to meet this goal is effectively 2 month's away, given that December is our annual Christmas Luncheon with the Ladies. (BTW - Be prepared to buy your tickets, which will be available starting with the coming October 13th luncheon. See our little Sir's article in this edition of our newsletter.)

While we are very excited to have had 16 new members join us so far this year, we have experienced an unexpected number of losses in membership: We have been saddened by the loss of several members who passed away this year; three of our men asked to be placed on inactive status, and some have moved out of the area. We are also struggling with our goal to invite 27 guests as prospective new members. At present, we have invited 19 guests. However, November will be the last month in which we can induct new members this year. Guests in November will potentially be inducted in January 2016. So guests we invite on October 13th will be the last po-

tential new members this year.

Where do we stand? As mentioned above, our 2015 year-end membership goal is 159. Right now, we are at 150. We need at least 9 guests in October who will join us as new members in November.

Action Item - watch for friends, neighbors, new acquaintances who are "missing out", and invite them to be your guest at the October luncheon. In anticipation of being overwhelmed with guests, in Bill Konold's absence be sure to let Tom Kirtley know of any guests you plan to bring (925-240-8071) so we have enough food.

# **Annual Dues**

In 2015, 94% of our Branch's members paid the suggested voluntary contribution of \$20 toward the financial support of our Branch and the SIR Inc. organization. A few of our members have even contributed further by telling us to "keep the change" when signing in for lunches. We are very grateful for all of this support. expenses, and even gives our Branch the ability to periodically provide encouragement to our members or their families during times of extreme personal challenge or loss.

While there is still not an initiation fee for joining SIR, a couple of years ago, the SIR Inc. Board revised the Rule on annual contributions by including the option for the Branches to collect mandatory annual dues. A number of successful SIR Branches have made this change to help ensure their continued ability to meet their financial commitments.

At their September meeting, our Board approved the collection of mandatory dues beginning with 2016. Our Board agreed to keep the amount of the dues at the present amount of \$20.00. Because there is no change in the amount to be paid in support of our annual expenses, implementation of this change will effectively go unnoticed for just about all of our members.

# **Membership Requirements & Principles**

Membership is open to men retired from full time occupation, regardless of age, race, color or religion. There are no dues, fees or assessments. Member volunteers and staff administer and govern all branch activities. Voluntary member contributions provide for these activities. SIR supports no outside cause or interest. We prohibit discussions of politics and religion or the selling of anything to any member. The only requirements to join SIR are that a man be retired, or semi-retired, and sponsored by an active member.

# Attendance Policy (Revised July, 2012)

Luncheon meetings are normally held on the second Tuesday of the month at the Discovery Bay Country Club, 1475 Club House Drive. (There are exceptions to when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this issue).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion. If you cannot attend, you are required to notify the Attendance Chairman by the Friday prior to the luncheon meeting or you may be charged for the luncheon.

Regular members missing three consecutive meetings without notifying the Attendance Chairman, or missing more than five (5) meetings within the last 12 months for any reason (not counting May and December), will have their membership reviewed by the Branch Executive Committee (BEC), and may receive a notice from the BEC of their decision to consider terminating the absent Sir's membership.

Certification of attendance at another branch will be considered a credit to attendance.
