## Golf News, Johnny Welton

Rain, rain, go away – come again another day! Well it rained but the pro at Swenson Park was kind enough to let us out of our contract on Monday before the Tuesday event. Everyone was happy not to be playing in the rain, hail, or lightning!



The Swenson Park event may be rescheduled – keep an eye out for an announcement.

We have two events that will come up quickly:

1. Manteca Park on 5/19 has only 26 players. Time to sign up.
2. Elkhorn 2 on 6/16 has a new deadline: June 1.

The course requires this because we will have space for 50 players or more. Sign up now. This is our competition with SIR Branch 8 Concord. Twenty players will compete from our branch, but I have arranged for anyone that wants to play to be able to participate (there may be prizes, too!). Please sign up early and pay. Only 21 are registered at this time.

Hopefully everyone knows that I will not be the Golf Director next year. You should also know that no one has been found to take the job in 2027. Many have been pursued by several SIR leaders. It is a confounding situation. I know you have appreciated how I have conducted the golf program, but it can be done in many ways. The new Golf Director would certainly be encouraged to provide a program that fits his needs and style. That requires a new Golf Director to be installed.

But what if there was a totally different approach? We require membership in the NCGA/GHIN system to use the handicapping system - to be able to compete. We pay extra and in advance to be able to prove prizes for the competition. Minimum posting of scores is required (or penalized) to conduct fair competitions. Cart Instructions, teams, and Scorecards are created to make a fair competition. Prizes are awarded for each event to reward those that are successful in the competition. What if in 2027 we didn't have a golf program led by a Golf Director? What if we didn't have golf events that included competitions?

The Golf Committee could assume the required minimum duties (representation at BEC, communication with golfers, check-in at events, etc.)...

- A schedule of six events would be contracted and scheduled for 2027.
- Prices would be set for each event at the rate contracted/charged with/by the golf course.
- Players would pay the golf course directly upon arrival for each event.
- Players would arrive at the venue one hour before the event and organize themselves into groups based on tee times.
- No prizes would be awarded.
- No NCGA membership requirement, no handicap used, no posting of score requirement, no rules, no competition, etc.

This type of structure has worked well for other organizations including SIR Branch 8 Concord. They hold events in this way 3-4 times per week all year long. It is easier to manage for leaders and cheaper for each member that participates.

I will step down as the Golf Director at the end of this year. However, I will continue to serve other members of the SIR organization in other ways. It is my duty and responsibility. I love the support, friendship, and activity SIR has provided me. The Golf Program will continue to evolve to meet the needs of those who want to participate in golf. Success of both will be based on the contributions in service made by others. No member should feel immune from the responsibility to serve others.

It is not the Golf Program that I am concerned about, but the very existence of the SIR Branch 161 I love.

## Attendance Policy

Luncheon meetings are held on the first Tuesday of the month at Club Los Meganos at Trilogy in Brentwood. (There may be exceptions when we need to hold our meetings on a different Tuesday, so please check the Meetings Calendar elsewhere in this newsletter).

Social hour is at 11.00am and lunch is at noon. All members are expected to attend Luncheon meetings unless prevented by illness, absence from the Branch locale, or acting as a caregiver to a spouse or companion. If you cannot attend, you are required to notify the Attendance Chairman by the Friday prior to the luncheon meeting or you will be assessed a fee for the luncheon.

Regular members missing three consecutive meetings without notifying the Attendance Chairman, or missing more than five (5) meetings within the last 12 months for any reason (not counting May and December), will have their membership reviewed by the Branch Executive Committee (BEC), and may receive a notice from the BEC of their decision to consider terminating the absent Sir's membership.
